## 4. First-aid measures

### Description of first aid measures

General information	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

**Protection of first aiders** *First aid personnel should wear appropriate protective equipment during any rescue. ## 5. Fire-fighting measures

### Extinguishing media

### Advice for firefighters

### Methods and material for containment and cleaning up

Methods for cleaning up      *Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Eliminate all ignition sources if safe to do so. No smoking, sparks, flames or other sources of ignition near spillage. Do not allow material to enter confined spaces, due to the risk of explosion. Provide adequate ventilation. Approach the spillage from upwind. Small Spillages: If the product is soluble in water, dilute the spillage with water and mop it up. Alternatively, or if it is not water-soluble, absorb the spillage with an inert, dry material and place it in a suitable waste disposal container. Large Spillages: If leakage cannot be stopped, evacuate area. Flush spilled material into an effluent treatment plant, or proceed as follows. Contain and absorb spillage with sand, earth or other non-combustible material. Place waste in labeled, sealed containers. ## 7. Handling and storage

### Precautions for safe handling

Appropriate engineering controls	<i>Provide adequate ventilation.
