4. First-aid measures

Description of first aid measures

General information	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

Methods for cleaning up

Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Approach the spillage from upwind. Small Spillages: If the product is soluble in water, dilute the spillage with water and mop it up.
