#### Description of first aid measures

Do not handle until all safety precautions have been read and understood. Do not handle broken packages without protective equipment. Do not reuse empty containers.

Appropriate engineering controls

Provide adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls as the primary means to minimize worker exposure. Eye/face protection
