## 4. First-aid measures

### Description of first aid measures

**Methods for cleaning up** *Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Provide adequate ventilation. Approach the spillage from upwind. Small Spillages: If the product is soluble in water, dilute the spillage with water and mop it up.
